11) Affiliate reports

HEU – Developed resource package for appointing worker reps to OHS committees. Six employers have applied for variances for joint committees. Implementing Musculoskeletal Injury Prevention (MSIP) pilot project.

PSAC – Basic training has been scheduled for members until end of June. Virtual convention end of May.

CUPE – OHS committees are struggling in all provinces with similar issues as in BC. Post-fatality investigation found that the City of Vancouver committees were not operating effectively. No tool-box meetings and some disbanded during COVID-19. Hoping to conduct a committee survey.

UBCP/ACTRA – Lori just back to work from workplace injury. Quiet in film, still some concerns with mandatory vaccine policies. Stunt performers agreement to donate their brains to the Boston Brain Bank for research.

USW – Long-time director Steve Hunt defeated in election. New director is Scott Lunny. May 9, 2022, is 30th anniversary of the Westray Mine disaster. Similar causation factors to the BC mill explosions. Alberta changing OHS legislation, red-tape exercise! Union workers must file grievance for discipline for refusing unsafe work. Non-union workers can go through regulation process.

CUPW – Employer continues to supply non-medical masks but no N95s. Starting up joint OHS committee training again. Union is updating and appointing their worker reps on committees. Cleaning contractors are using an unapproved product to fog workplaces at night and causing breathing problems, rashes from residue left behind. 10 claims to WCB. Cleaning has always been done badly with no training for workers. COVID-19 showed the gaps.

FPSE – Remote work, employers are demanding that protocols are in place in workers' homes.

IBEW – Still dealing with issues from the COVID-19 vaccine mandates. Joint committee not working well. Safe work practices not being communicated to workers by the employers. Continue to meet with employers to try to resolve.

GWU – Interested in ILWU position on Russian invasion of Ukraine.

BCGEU – Focus on bargaining taking time and energy. On-line courses continuing with inperson resuming April 1st. Participants will be required to be vaccinated and do rapid testing. Commercial Vehicle Safety and Enforcement (CVSE) non-compliance agreement for violence and working alone has been extended. WCB officer doing a good job. Union has been supporting investigation into death of Randy Sandberg a highways maintenance worker.

CEU – Welcome to Erin Guy who is new to committee. Erin is a WCB hygiene officer. Our friend Paul Bergin is running for VP.
