#### 6) PPCC update

- Met on September 27, 2022
- Further amendments to the proposed first aid changes. Lowering of requirements and will rely upon employers to do a risk assessment. Lots of feedback at public hearings
- Bill 5, asbestos regulation: PRRD drafting language with information-gathering session in November. Job analysis has been completed with four workers, 17 employers and six experts. Participants will be asked to review report
- Violence regulation review update. Small sub-committee will participate in the next preconsultation session on October 21st
- Good feedback from consultation on on-traumatic hearing loss

The <u>BCFED statement on harassment</u> applies to all our events.

- Public hearing on December 16 for proposed amendments to Hazardous Drug regulation (formerly Cytotoxic Drugs)
- Discussion on hazard rating system: not transparent, reliance upon for certain regulations (first aid). PRRD will do a scan of when it is used and come back to PPCC

# 7) Workers Deserve Better campaign

- BCFED met with the WCB Board of Directors. Main point made was the ongoing concerns with a lack of robust consultation with labour. Committees dismissed during COVID-19 and lack of consultation on COVID-19 safety plans

#### 12) Affiliate reports

**BCGEU** – Held conference for OH&S facilitators, Component 10 OH&S conference and admin services conference at Harrison. 26 OH&S courses running in public service. Evident there are inconsistencies in fire code regulation between municipalities.

**CUPE** – Concerns about increase in psychological injuries and application of CSA standard on psychologically healthy workplaces. In eighth wave of COVID-19, pandemic is not over and concerns for the long-term impact on workers' health.

**HEU** – Planning convention for early October. Ratification voting taking place. Continuing variance applications for committees coming from private care employers. Employers are rewriting committee terms of reference without consulting with workers reps. WCB has not been helpful in resolving issue.

**ILWU** – Significant injuries and having problems getting investigators as required under Par 2 of the *Labour Code*. Illegal Strike with no consequences.

**ILWU-GWU** – All good on the waterfront. Working on averaging agreements.

**PSAC** – Likely mediation for collective agreement bargaining. Could be on strike in early 2023. Planning national health and safety conference.

**UBCP/ACTRA** – Some productions still have vaccine mandates. Difficult on union staff dealing with cranky members.

**USW** – Held summer school in Kimberly including gathering of Indigenous workers. 1<sup>st</sup> inperson event with a huge turnout and members very happy.
