## ELIGIBILITY

- Eligibility for the FSA President and Vice President positions is limited to full-time members.
- Associate FSA members (this includes all current Part-time Studies Instructors and Lab Assistants) are ineligible to be a candidate for the President and Vice President positions.
- Ancillary FSA members (Markers, Student Employees and Guest Lecturers) are ineligible to be a candidate for the President and Vice President positions.
- All FSA members may *nominate* and *vote* for these positions.
